## Overview

Jayne has extensive experience in disease, high value personal injury, clinical negligence, fraud and sports claims.

She is frequently requested by insurers to advise and represent in cutting-edge disease claims.

She is often invited to provide lectures in all of the areas above, but particularly in the industrial disease field to both solicitor and insurer clients.

## **Expertise**

#### Disease

Having spent pupillage working on the leading disease case of *Thompson v Smiths Shiprepairers (North Shields) Ltd* [1984] QB 405, Jayne has worked in the industrial disease field for the whole of her career.

Working on all aspects of disease claims at Multi Track level, with a particular interest in asthma, cancers and chest diseases, asbestos work forms a significant part of practice.

Regular appearances before the Specialist Masters on show cause and all interlocutory matters are combined with trials and appeals on limitation, liability, causation and quantum. Jayne has been involved in group actions involving exposure by the Fire Service to allegedly contaminated water in rescue training and RADS claims arising from work in petroleum columns, as well as new claims in resurgent areas of silicosis and tuberculosis.

She has also been involved in air contamination, wood dust and aspergillus claims.

Recent cases have included *Hill & Billingham v Lloyds British Inspections Services Ltd & Others* [2013] EWHC 520, establishing the test for exposure between 1965 and the introduction of the Asbestos Regulations 1969 to be measured by TDN 13, *Dalton v Gough Copper & Co Ltd* [2014] EWHC 1556, an appeal from an Asbestos Master leading to setting aside judgment in default and ultimately discontinuance of the claim, and *Robinson (Personal Representative of Frederick Lugay Deceased) v Hammersmith & Fulham LBC* [2017] EWHC 1823 where the local authority successfully defended allegations of breach of duty in a mesothelioma claim arising from occupancy of local authority housing.

Jayne also provides generic and strategic advice for insurers in relation to matters which affect claims generally, including public liability claims, disputes between insurers and, most recently, the approach to be taken to immunotherapy claims in mesothelioma. She regularly provides lectures and training within this sphere.

#### Personal Injury

Jayne has practised in the personal injury field throughout her career, with the emphasis now on high value and catastrophic claims as well as those with a generic or strategic angle. That work has also involved stress at work and bullying claims.

Jayne has extensive expertise in spinal and major head injury claims as well as physical conditions generally, chronic pain type conditions and psychiatric/psychological injuries. Whether arising from road traffic accidents, accidents at work, construction sites or product liability, Jayne has worked in that area.

Jayne was junior counsel on the Leicestershire, Bryn Alyn and North Wales Abuse in Care Litigation and has experience of many hundreds of such abuse claims in the context of limitation, breach of duty, medical causation and quantum.

#### Serious Injury

Jayne has practised in the personal injury field throughout her career, with the emphasis now on high value and catastrophic claims as well as those with a generic or strategic angle.

She is regularly involved in seven figure claims arising from physical injury, predominantly spinal, brain and head injury as well as chronic pain and psychiatric type conditions whether on liability, medical causation or quantum.

Jayne is used to preparing extensive schedules and counter-schedules, advising on risk and value, and running claims to trial as well as carrying out joint settlement meetings and mediations.

Apart from very serious motor claims, recent cases have involved cauda equina injuries, systemic damage from sewage contamination, stress at work involving termination of high powered careers both for Claimant and Defendant and claims involving intervening clinical events.

#### Counter Fraud

As a personal injury practitioner throughout her career, Jayne has always considered fraudulent claims as an inherent part of that work.

Every claim requires a forensic analysis of the truth or otherwise of a claim. Whether looking at exaggeration, dishonesty in terms of symptoms or downright fraud in relation to the occurrence of the event in question, Jayne has fought many such cases.

Most recently. Jayne was successful in a case spanning fifteen years of her practice, as counsel throughout and then junior counsel on the Supreme Court decision of *Colin Hayward v Zurich Insurance Company Plc*. Having been counsel on the original claim, Jayne then advised on the prospects of setting aside a Tomlin order in the case of fraud, successfully ran the action claiming fraud to trial and ultimately succeeded, with Patrick Limb KC, in persuading the Supreme Court of the force of the first instance decision. The insurer was able to claim back those sums which had been overpaid as a result of the original fraudulent exaggeration of injury. This decision has far reaching consequences for the approach to fraudulent claims.

#### Clinical Negligence

Jayne has extensive experience in the clinical negligence field as well as being a member of a local drugs related research ethics committee and for 10 years sitting as the chairperson of the CARE fertility services ethics committee.

She is the President of the Nottinghamshire Medico-Legal Society (2017-2018).

Jayne has advised on IVF and surrogacy related issues in the clinical negligence area. More regularly, Jayne has appeared in actions against NHS Hospital Trusts, GPs and individual Consultants working in the private sector. Such work has included, as well as birth and immediate post birth injuries / failures involving the child, a number of serious birth injuries from the context of injury to the mother. She has also dealt with TVT, kidney and urinary injuries, life changing injuries to sight and the creation of prescription drug addiction. Jayne has also appeared in numerous inquests arising from alleged medical errors.

#### **Sports**

Jayne has acted in several interesting sports-related cases, including a number of claims for the British Gymnastic Society involving high level gymnastics and trampolining injuries.
