## Overview

Tom is a specialist in claims for serious injury, chronic pain, and work-related stress.

In more than twenty years at the Bar he has built a practice based primarily on complex or multi-party liability disputes and high-value quantum cases.

A significant element of Tom's practice is now devoted to employers' liability for psychiatric injury caused by work related stress, bullying and harassment.

#### **Employer's Liability**

Tom is regularly instructed in:

- · Accident cases involving all key EL areas (especially construction and work equipment)
- Multi-party CDM disputes involving complex control issues
- Workplace stress, bullying and harassment cases, including cases against local authorities, the police, and commercial organisations
- Workplace violence, particularly in the social care context (Tom is very much alive to the sensitivities of these cases
  and used to being involved from the early stages, dealing with disclosure involving multiple agencies and sometimes
  complex data protection issues).

#### **Quantum Cases**

Particular emphasis on cases involving:

- Brain injury including disputes over whether any TBI sustained
- Chronic pain (including Complex Regional Pain Syndrome and Functional Neurological Disorder)
- Amputations, usually in the EL context
- Fatal accidents: Tom has represented both claimants and defendants in FAA claims for many years and is known for his
  careful, conscientious and sensitive handling of this most taxing and stressful type of litigation. He is used to bringing
  £1million-plus claims to settlement before court proceedings become necessary, and handling difficult disputes
  between defendants. Tom welcomes early involvement from the Inquest stage, and (for defendants) close
  coordination between the teams responsible for regulatory and civil actions.

#### **Product Liability**

Tom has considerable experience of Consumer Protection Act personal injury cases involving a diverse range of products from cosmetics, to domestic tumble dryers, to substantial pieces of plant, frequently overlapping with the EL context.

#### Disease

#### Work-related Stress/Psychiatric Injury

Tom's experience of work-related stress claims encompasses a wide variety of workplace situations including:

- Local authorities, particularly in relation to employees engaged in SEND activities and social work
- Policing (including front-line officers and support staff)
- Health service including complex environments such as psychiatric institutions
- Commercial defendants including large financial institutions
- Bullying/harassment cases as well as 'Hatton-typical' cases relating to overwork etc

#### Vibration, Noise and Dust Diseases

Bloor v Anchor Hanover Group [2024] EWHC 1772 (KB). Employer's duties in respect of risk assessment in relation to a live-in employee at a supported housing scheme.

Brown v South West Lakes Trust, South West Water Ltd and Cornwall County Council [2022] EWCA Civ 18. Local authorities' duties in relation to the construction and design of highways; duties of occupiers to highway users unintentionally trespassing off the highway onto their land.
