### Overview

#### **Notable Cases**

**Newark and Sherwood Homes v Gorman** [2015] **EWCA Civ 764.** Challenging an order declaring on a preliminary issue the council had elected to operate an introductory tenancy regime for the purposes of Section 124 of the 1996 Act and that the tenancy granted by the respondent to the appellant was an introductory tenancy for the purposes of part V of the 1996 Act.

*R v Criminal Injuries Compensation Appeals Panel, Ex Parte Bennett, Independent, October 2, 2000.* Judicial Review of the CICAP's interpretation of the notion of a 'disabling mental condition' for the purposes of the CICA's tariff.

## Police Law

Andrew has experience of handling claims involving unlawful arrest and detention, including allegations of the use of excessive force and the deployment of dogs to assist with arrest.

He has extensive experience of employers' liability claims, including injuries sustained during training exercises and violence at work.

In particular, he has considerable specialist knowledge of the inquest process, especially in the context of restraint during arrest and deaths during detention.
